**NOTIFICATION**

In exercise of the powers conferred by sub-section (1) of section 10-A of the Rajasthan Stamp Act, 1998 (Act No. 14 of 1999), the State Government hereby directs that all departments of the State Government, Institutions of Local Self-Government, Semi Government organizations, banking or non-banking financial institutions or the body owned, controlled or substantially financed by the State Government or any class of them, specified in column number 2 of the Schedule appended hereto, shall ensure that the proper stamp duty is paid to the State Government through electronic Government Receipt Accounting System (e-GRAS) in respect of the instruments specified against them in column number 3 of the schedule.




